## Announcement of the Publication of a Prospectus and Fundraising

**Spinnaker Acquisitions plc**, a company formed for the purpose of undertaking an acquisition or acquisitions of a majority interest in a company, business or asset, is pleased to announce that the Prospectus dated 14 July 2021 has been approved by the Financial Conduct Authority (the "**Prospectus**") in connection an application for admission of the enlarged Ordinary Share capital of the Company to the Official List (by way Standard Listing under Chapter 14 of the Listing Rules) of the Financial Conduct Authority and to trading on the London Stock Exchange's Main Market ("**Admission**"). The Company intends to focus on opportunities in the sustainability and/or energy transition sector(s), but the Company shall not be limited to such sector.

In connection with Admission, the Company will subject to and conditional upon Admission, issue a total of 20,810,000 ordinary shares having a nominal value of £0.05 each ("**Ordinary Shares**"), at an issue price of £0.10 per share (the "**Fundraising**"), pursuant to a subscription and a placing co-ordinated by the Company's brokers, SI Capital Ltd, to raise gross proceeds of £2,081,000. In addition, participants in the Fundraising will be issued with one warrant for every two new Ordinary Shares subscribed for with an exercise price of £0.20. The warrants will have a four-year exercise period from Admission.
